

Senior Trip Candy Sale Contract

Please Read Carefully

You are being given the opportunity to sell candy to help defray your cost of the **voluntary** senior trip to Disneyland May 23-24, 2019. Seniors who wish to participate in the candy sale must turn in a completed contract to Mrs. Fulbright (SBO) **before Friday, November 16th**. You must personally give this form to Mrs. Fulbright.

BY SIGNING THIS CONTRACT, YOU ARE AGREEING TO BE RESPONSIBLE FOR ONE "CASE" OF CANDY AND AGREE TO THE PROVISIONS OF THIS CONTRACT. YOU UNDERSTAND THAT YOU MAY NOT SELL CANDY ON CAMPUS.

After selling your "case", you are to turn in your \$60.00 to Mrs. Fulbright in the SBO. Only currency, or checks (**NO COIN**) may be turned in. You will then be given a credit of \$23.00 towards your senior trip ticket. You may sell as many "cases" as you would like from

November 26th – December 7th and January 28th – February 8th

You may only check out one "case" at a time. You may pick up your first case on November 26th from Mrs. Fulbright in the SBO.

If for any reason you should decide not to attend the senior trip and/or become ineligible to attend the trip, the monies derived from your selling of candy shall be left in the senior trip fund. Money derived from selling candy is non-transferable.

The deadline for turning in your candy money for credit towards your senior trip is Friday, February 8th, 2019. As of February 8th you must pay the full balance due for the cost of the Senior Trip \$315. Selling candy or placing a deposit does not hold your place on the Senior Trip. **Spaces are determined on a first-come, first-serve basis dependent on FULL payment, not participation in the candy sale.** Only full buses will be scheduled. Partially filled buses as of February 8th will be cancelled and students on that bus will be placed on a waiting list. This cut-off date is necessary because we have to confirm our final count with Graduate Tours.
