RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT (Graduation Night)

I, the undersigned, hereby release and discharge the Modesto City Schools District, its officers, employees, agents, servants and volunteers (herein collectively referred to as the "district") from all liability arising out of or in connection with the above-described event(s), including but not limited to hypnosis demonstrations, any activity occurring off the district's property, or all liabilities associated with any and all claims related to such events(s) that might be filed on behalf of or for the above-named student. For the purposes of this agreement, liability means all claims, demands, losses, causes of action, suits or judgments of any and every kind that occur during or incidental to the above-described event(s), including but not limited to hypnosis demonstrations, any activity occurring off the district's property, and that results from any cause whether caused by the negligence of the district or otherwise.

I hereby agree to indemnify and save and hold the district harmless from any loss, liability, damage, or cost that it may incur arising out of or related to the event(s), including but not limited to hypnosis demonstrations, any activity occurring off the district's property, whether caused by the negligence of the district or otherwise.

I HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE ARISING OUT OF OR RELATED TO THE EVENT(S), INCLUDING BUT NOT LIMITED TO HYPNOSIS DEMONSTRATIONS, ANY ACTIVITY OCCURRING OFF THE DISTRICT'S PROPERTY, WHETHER CAUSED BY THE NEGLIGENCE OF THE DISTRICT OR OTHERWISE.

I HEREBY ACKNOWLEDGE THAT THE ACTIVITIES IN THE EVENT(S) MAY INVOLVE RISKS OF BODILY INJURY AND/OR PROPERTY DAMAGE. THE UNDERSIGNED ALSO EXPRESSLY ACKNOWLEDGES THAT INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE DISTRICT.

I hereby agree that this release and waiver of liability, assumption of risk, and indemnity agreement extends to all acts of negligence by the district, including negligent rescue operations, and is intended to be as broad and inclusive as is permitted by the laws of the state of California, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND FULLY UNDERSTANDS ITS TERMS AND THAT THE UNDERSIGNED HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAS SIGNED IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT OF ANY KIND OR GUARANTEE BEING MADE AND THE UNDERSIGNED INTENDS BY HIS/HER SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
